

RESOLUTION NO. 2014-18-F

**RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX
IN EXCESS OF THE TEN-MILL LIMITATION**

WHEREAS, the amount of taxes which may be raised within the ten mills limitation will be insufficient to provide an adequate amount for the necessary requirements of the Village of Greenhills, Hamilton County, Ohio; and

WHEREAS, the Village Council has determined that in order to continue to provide for the current operating expenses of the Village associated with street repair and maintenance that it is necessary to renew the existing 1.5 mill operating levy of the Village; and

WHEREAS, the Hamilton County Auditor has certified to the Village Council that the dollar amount of revenue that would be generated by a levy of tax at a rate not exceeding 1.5 mills for each one dollar valuation equals \$36,028 based upon the total estimated tax valuation of the Village of \$55,654,200.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Greenhills, Hamilton County, Ohio, two-thirds of all members elected thereto concurring.

SECTION 1.

That it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Greenhills, pursuant to ORC §5705.19(G), for general construction, reconstruction, resurfacing and repair of streets, roads and bridges within the municipality at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to \$1.50 for each one hundred dollars of valuation for five years and which levy is a renewal of an existing levy of 1.5 mills.

SECTION 2.

That the question of levying additional taxes be submitted to the electors of said Village of Greenhills at the November election to be held at the usual voting places within said Village of Greenhills on the 4th day of November, 2014.

SECTION 3.

That said tax levy be placed upon the tax list of the current year after the February settlement next succeeding the election, if a majority of the electors voting thereon vote in favor thereof.

SECTION 4.

That the Clerk of the Village of Greenhills be and is hereby directed to certify a copy of this resolution to the Board of Elections, Hamilton County, Ohio and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

SECTION 5.

That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 6.

This resolution shall be in full force and take effect upon its passage.
